Eligibility

1. This scholarship is open to any student entering or currently attending a Junior College or 4-year College or University and who is a graduate of a Miami-Dade County High School.
2. Student must be pursuing a degree in horticultural sciences, landscape architecture, or other related agricultural field.
3. Student must have 2.5(B) or above Grade Point Average (GPA).
4. Student may reapply annually as long as they maintain a 2.5 GPA.
5. Student must also maintain full-time status as a student to be eligible for scholarship.

Requirements

1. Complete scholarship application in full.
2. Provide an official transcript for the current year.
3. Complete Essay.
4. Enclose requested letters of recommendation.
5. Incomplete applications will not be considered. Also, application must be typed or printed legibly.
